FOURTEENTH MAHAVEER AWARDS

We invite nominations for the Fourteenth Mahaveer Awards for Excellence in Human Endeavour in community service mainly in the following spheres of activities:-

- ❑ Propagation of Non-violence and Vegetarianism
- ❑ Education
- ❑ Medicine
- ❑ Community and Social Service

There would be four awards each of them consisting of a cash component of Rs.10 Lakhs, a Citation and a Memento.

Only individuals who are Indian Nationals and institutions based in India and doing work of a very high standard in India would be eligible for these awards. Work carried out during recent times would merit consideration. One major criteria for making the award would relate to the benefits reaching the economically and the socially backward sections of the community e.g. SC/ STs, women and children.

Moreover, such individuals or institutions should be sponsored by others who are not related to the individuals or directly associated with the management of the institutions.

The evaluation of the nominations will be done by a Selection Jury headed by Justice Sri M N Venkatachaliah, former Chief Justice of India and includes other persons of eminence. The decision of the Jury would be final.

The format for the nomination is furnished in the latter part of this letter. The format can also be downloaded from our website: www.bmfawards.org.

Kindly send the nominations for any individual or institution who merits any of the above awards at an early date to avoid rush of nominations towards the last date for their receipt.

The last date for receipt of the nominations is 28th February 2010. Since the selection process is time bound, we regret that nominations received by us after 28th February 2010 would not be taken into consideration for the **FOURTEENTH MAHAVEER AWARDS**.

4. Please avoid expensive enclosures. Only one Xerox copy of the enclosures need be sent. Originals need not be sent. We regret that it will not be possible for us to return the material sent to us in support of the nomination.
5. Please specify the sphere of activity for which the nominee is sponsored.
6. Please affix a copy of the recent passport size photograph of the nominee in the space provided for in the nomination form.
7. In case of institutions specify, whether it is a registered society or trust.
8. Please indicate the broad sources of finance supporting the activities of the nominee (e.g. grants from Government, donations from Indian / Foreign sources).
9. Any other relevant information: These should be brief and relevant.
10. All disputes relating to the awards are subject to the jurisdiction of the courts at Chennai only.
